This resulted in both proprietary and short courses suffering lower student intakes.	
5.4	HT (DW) shared that SHRI Academy only had two events organized, that is HR Hackathon and HR Outlook. HR Awards, traditionally a revenue generator for SHRI had to be delayed to FY 2023, hence the drop in revenue.
